Subject: Final Actions from Fall 2007 of the Undergraduate Policies and Curriculum Committee, The Graduate Policies and Curriculum Committee, and the Faculty Senate

Approved Undergraduate Policies and Curriculum Committee Recommendations

These approvals are reflected in the 2007-2008 online undergraduate catalog (spring 2008 updates). Additionally, these updates will be included in the 2008-2009 undergraduate catalog.

Board of Regents

The Board of Regents, at their August 2007 meeting, approved a major in International Business under the existing B.B.A. degree.

College of the Arts

A new major in Dance under the existing Bachelor of Arts degree was approved by the UPCC. A preliminary proposal for this new major is currently under review at the Board of Regents.

College of Humanities and Social Sciences

- African and African Diaspora Studies changes major as follows:
 - AADS 2100 Introduction to African and African Diaspora Studies takes the place of GEOG 1101.
 - AADS 2260 Research Methodologies replaces HIST 2206.
 - AADS 4499 Capstone replaces the capstone courses in English and History.

Additionally, the new major was brought through the UPCC for approval as it was not brought through after Board of Regents approval three years ago.

- Communication major makes several changes to program:
 - Change in title for COM 4480 to Communication Theory.
 - Removal of COM 4499 Senior Thesis as option under Organizational Communication concentration requirement and under Public Relations concentration requirement.
 - Addition of COM 4460 Crisis Communication as option under Public Relations concentration elective.

College of Science and Mathematics

- Biochemistry makes several changes to major including:
 - Removes option of elective credits taken from lower division course work to ensure all biochemistry students meet university wide degree requirement of 39 upper division credits.
 - Bioinorganic Chemistry Lab I is changed to Bioinorganic Chemistry Lab.

- Change names of several courses – see Undergraduate Course Changes (CHEM) below.
- Chemistry Education Track under Chemistry B.S. makes several changes including removal of CHEM 3501/L, CHEM 3110, and CHEM 3110L and replacing these with CHEM 3500/L, CHEM 3120, and CHEM 3105L. These changes give Chemistry Education majors much better exposure to all aspects of biochemistry.
- Forensic Chemistry Track makes change under upper division major requirement by removing CHEM 3501/L and replacing it with CHEM 3500/L.
- General Chemistry Track makes changes under upper division major requirements by removing Chemistry Electives – 6 credit hours and replacing with CHEM 3500 Biochemistry (3 credit hours) and Chemistry Elective – Any 3000/4000 level chemistry course (3 credit hours).
- Chemistry Professional Track makes changes including changing the Biochemistry major requirement from CHEM 3501/L to CHEM 3500/L. This change gives all professional chemistry majors much better exposure to all aspects of biochemistry.

Final Actions on Recommendations for Faculty Senate Actions—Fall 2007

- Faculty Senate Bylaws Amendment process unanimously approved at the 9/10/07 Faculty Senate meeting.
- Proposal for Departmental Bylaws and Department Faculty Council (DFC) recommended by Faculty Senate in spring 2007 and approved by Senate Executive Committee, the Provost, and the University President during the summer 2007.
- Proposal for College Bylaws and College Faculty Councils (CFC) recommended by Faculty Senate in spring 2007 and approved by Senate Executive Committee, the Provost, and the University President during the summer 2007.
- A completely reworked section on Faculty Workload is approved by the Provost in the summer, 2007 term.
- A major reorganization of Faculty Handbook - Section 3 (Instructional Responsibilities) is completed . Procedures (e.g., syllabus format) were pulled out and placed into two appendices. The remaining text of the body of Section 3 refers to policy related to workload. The Faculty Senate asked CETL to have the procedural information found in the appendices available on their web site.
