## Approved Undergraduate Policies and Curriculum Committee Recommendations

These approvals are reflected in the 2007-2008 undergraduate catalog.

#### Board of Regents

• At its April 18, 2007 meeting, the BOR approved KSU's request to establish a major in Geography under the existing Bachelor of Arts degree.

#### College of the Arts

- Major in Fine Arts makes changes to program to reflect curriculum changes and updates existing text describing the program.
- Major in Theatre and Performance Studies makes several adjustments to their concentrations to reflect the maturation of the major.

## Bagwell College of Education

- College of Education makes changes in Admission/Retention policy to reflect Board of Regents mandate for course changes in Area F.
- Majors in Elementary and Early Childhood Education, Middle Grades Education, Biology Education, Chemistry Education (Track), English Education, History Education, Mathematics Education, Art Education, Modern Language and Culture – Teacher Certification concentration, Health and Physical Education, and Music Education make changes to reflect Board of Regents mandate for course changes in Area F.
- Major in Health and Physical Education makes changes on their progression/retention policies. The updated policy is as follows:

"To ensure HPE candidates meet the standards required by the Professional Teacher Education Unit (PTEU), National Association of Sport and Physical Education (NASPE), and the Georgia Professional Standards Commission (PSC), all transfer students will be required to take all courses in the Professional Education sequence (HPS 3450, 3550, 3650, 3750, 4250, 4410, 4430 and 4850) at Kennesaw State University. Exceptions will be made only for those who took a course that in the past was considered a substitution for one of the Professional Education courses and can document their compliance with these standards through portfolio presentations of their work."

#### College of Humanities and Social Sciences

- Major in Anthropology makes changes to the program to reflect new specializations that can now be offered in this area. Included in this updated program are two new courses – Forensic Anthropology and Applied Archaeology.
- Major in English updates program to reflect new course prefix changes for their writing courses from ENGL to WRIT.
- BOR approved major in Geography is included in 2007-2008 undergraduate catalog. The program is being offered beginning fall 2007.
- History major makes changes to allow more flexibility in teaching a core history major requirement
- Major in International Affairs makes changes and adds POLS 4433. The major also clarifies the Foreign Language requirement to read:
  - "Foreign Languages (The 2001-2002 sequence must be taken in a single foreign language.)
- Major in Modern Language and Culture makes change to its program description which reads as follows:
  - "All majors must take an official Oral Proficiency Interview (OPI). In addition, majors choosing the "Teacher Certification in a Foreign Language" concentration must receive a **minimum** rating of "Advanced Low" to graduate and to receive a recommendation for certification. - Major in Modern Language and Culture Teacher Certification concentration makes change to its program to reflect a Foreign Language option in place of a PSYC course no longer offered.
- Political Science major changes lower division foreign language requirement to read:
  "2001-2002 sequence must be taken in a single foreign language"
- Sociology major makes change in lower division major requirements by replacing SSRM 2301 with SOCI 2301 – Research Methods in Sociology.

#### College of Science and Mathematics

- Major in Biochemistry adds CHEM 4500 in place of BTEC 4100 under upper division major requirements. Also supporting discipline changes gives students a greater choice of electives.
- Major in Chemistry (General Chemistry Track) makes several changes including:
  - 1. Addition of CHEM 3000
  - 2. General Education changed from 43 hours to 42 hours
  - 3. Specific description of electives in lower division major requirements is removed to encourage more flexibility but keep courses in College of Science and Math and at the 2000 level.
  - 4. Specific description as to the number of 3000-4000 level courses for supporting disciplines is being added.
  - 5. CHEM 3501/L is being moved to the chemistry electives since students should have the flexibility of choosing either CHEM 3501/L or CHEM 3500.
  - 6. CHEM 3110/L is removed under upper level major requirements and replaced with CHEM 3120 and CHEM 3105L.
- Major in Chemistry (Chemistry Education Track) makes the following changes:
  - 1. CHEM 3700 is removed from track and replaced with CHEM 3400.
  - 2. The 7 hours of chemistry electives are removed to allow students to pursue a second area of teaching interest.
  - 3. The 7 hours of chemistry electives are used to create additional areas of teaching interest within the supporting disciplines.
  - 4. Changes in EDUC courses reflect state-mandated changes in Professional Education sequence.
  - 5. EXC prefix is changed to INED to reflect name change for the department of inclusive education.

- Major in Chemistry (Forensic Chemistry track) makes changes to align the forensic chemistry program to meet the recommendations outlined by the National Institutes of Justice June 2004 Special Report "Education and Training in Forensic Science". These recommendations have been adopted by the Forensic Science Education Program Accreditation Commission (FEPAC) and are the current standards for accreditation by the American Academy of Forensic Sciences (AAFS). As we move toward accreditation of our forensic chemistry degree track, we must align our program of study to the curriculum guidelines specified by FEPAC and AAFS. The criteria for accreditation require the program make several modifications to the degree program.
  - 1. Require students take COM 1129 as a specific general education requirement to support FEPAC accreditation standards.
  - 2. Lower division major requirements are listed in full for clarity rather that saying "Same as General Chemistry track except the following..."
  - Lower division major requirements add MATH 1107 Elementary Statistics to support FEPAC accreditation standards. Lower division major requirements and remove CHEM 2100/L Forensic Chemistry.
  - 4. Upper Division Major Requirements remove CHEM 3010 Pharmacological Chemistry and add the following courses to support FEPAC accreditation standards:
    - CHEM 3000 Chemical Literature this course added because it is a prerequisite for CHEM 3105L
    - CHEM 3120 Descriptive Inorganic Chemistry this course is added to support FEPAC accreditation standards.
    - CHEM 3105L Inorganic Synthesis this lab is added to support FEPAC accreditation standards.
    - CHEM 3800/L Forensic Analytical Chemistry this course replaces CHEM 2100/L and is added to support FEPAC accreditation standards.
  - 5. Research or internship credits are reduced from 3 to 2 to accommodate the increased number of students choosing CHEM 4100 and account for the fact that there are a limited number of faculty conducting forensically relevant research. Also allows students to satisfy credits with CHEM 3540L Advanced Biochemistry Laboratory similar to the Biochemistry degree
  - 6. Supporting Disciplines removes BIOL 3300 Genetics and the BIOL or BTEC or ANTH elective and adds BIOL 3340 Microbiology OR BIOL 3338 Histology to support FEPAC accreditation standards for course content in microscopy.
  - 7. Free elective credits are reduced from 12 hours to 10 hours to keep the program total at 123 hours and adds "see advisor for recommendations"
- Information Systems major makes change in program to move ISA 3100 Principles of Information Security and Assurance from an elective course to a required course.
- Major in Mathematics makes several changes to the program. The following is a summary of these changes:
  - 1. The requirement of a formal "individualized curricular plan" that must receive separate approval for each student is discontinued. Specific concentration-based curricular plans are still in place, but all of these are pre-approved.
  - 2. The current 18 hours of "interdisciplinary electives" (3000 and 4000 level courses in disciplines related to mathematics) that are required is reduced to 12-15 hours. The heading "Interdisciplinary Electives" in the catalog program description is changed to "Concentration-Based Electives", reflecting the fact that these courses are chosen from a list of specific pre-approved courses taken to prepare the student for employment (or graduate level study) in various concentration areas (including, for example, actuarial, financial, pre-engineering, mathematics education, and applied statistics). In addition, the current 6 hours of Area F (2000 level) "Guided Electives" is also chosen from a set of pre-approved courses specific to whatever concentration area the student chooses to pursue.

- Each of these concentrations and their requirements is described in detail in the KSU Mathematics Major Handbook.
- 3. An additional 3-6 hours of upper level mathematics elective courses is required. (These are the 3-6 hours that are being removed from the interdisciplinary electives.)
- 4. Four new upper level courses are added: Linear Algebra II, Modern Algebra II, Real Analysis II, and Complex Variables. The initial offerings of each of these courses is once every two years, with future changes in frequency of offerings being made based on demand.
- 5. The existing upper level courses *Computational Linear Algebra* (MATH 3261) and *Numerical Methods* (MATH 4345) is renamed, respectively, *Numerical Methods I* and *Numerical Methods II*, reflecting the continuity of the material of this course sequence.
- 6. Certain new Statistics courses that were introduced and approved last year (with prefix STAT) will be included among the major electives for the mathematics major. These courses include STAT 3010, 3120, 3125, 3130, 4120, 4210, and 4490.

#### Revisions to Certificate Programs of Study

- Changes made to the Certificate in Forensic Chemistry are made in order to align the program to meet the recommendations outlined by the National Institutes of Justice June 2004 Special Report "Education and Training in Forensic Science."
- The Certificate in Applied Mathematics adds MATH 3260 as a required course and deletes MATH 4345 from the requirements; adds MATH 2203 in the list of free elective courses to encourage students to complete calculus sequence at KSU; name of MATH 3261 is changed to Numerical Analysis I.

#### Revisions to Minor Programs of Study

- Changes made to the Film Studies minor to reflect the new course prefix change for writing courses from ENGL to WRIT.
- Changes made to the Professional Writing minor to reflect the new course prefix change for writing courses from ENGL to WRIT.
- Gender Studies is revised to Gender and Women's Studies minor and the new GWST courses are included in the revised program.
- The minor in Applied Mathematics adds MATH 3260 as a required course and deletes MATH 4345 from the requirements; adds MATH 2203 in the list of free elective courses to encourage students to complete calculus sequence at KSU; name of MATH 3261 is changed to Numerical Analysis I.
- Minor in Applied Statistics increases the number of elective courses available for students.

# Final Actions on Recommendations for Faculty Senate Actions — Spring 2007

- The senators from that college operating as a caucus should select a college's representative to the President's Planning and Budget Advisory Committee (PPBAC).
- Faculty Handbook, Section Five–Review and Evaluation of Faculty Performance, Roman numeral II. Overview of Faculty Responsibilities is updated by adding fourth bullet.
  - clarify the general responsibilities and relative emphasis of the individual in teaching, supervising, and mentoring; research and creative activity; professional service; and administration and leadership;
  - o articulate the manner in which the faculty member's activities relate to the departmental and college mission and goals;
  - identify the expectations for scholarly activity and scholarship in the faculty member's areas of emphasis;
  - o identify the performance area(s) that will include scholarship expectations and describe those expectations.
- Faculty Handbook, Section Five-Review and Evaluation of Faculty Performance, Roman numeral IV. Evaluation of the Quality and Significance of Faculty Scholarly Accomplishments is updated as follows.

- While the professional activities of faculty vary, every faculty member is expected to demonstrate scholarly activity in all performance areas. Furthermore, tenure-track faculty members must produce scholarship in at least one of their performance area(s) of emphasis. The performance area(s) with scholarship expectations must be agreed upon by the faculty member and the faculty member's supervisor. In other words, although faculty members are expected to engage in scholarly activity in all the performance areas identified in their FPA, they are not expected to produce scholarship in all areas. Evaluation of all scholarly accomplishments and scholarship will be based on evidence of the quality and significance of the work.
- Process by which Standing Committees report to the Senate be the same procedure adopted by the University Council. The procedure requires the chair of each Standing Committee provide minutes of its meetings to the Senate's President's elect in a digital form for posting on the Senate Web site. If the committee did not meet during a particular semester, the chair is required to write a brief memo to the President-elect explaining why no meeting had been necessary. This memo would also be posted to the Senate Web site.
